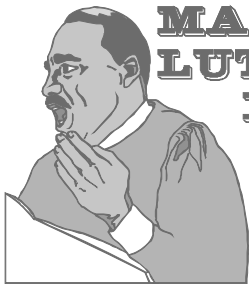



Planning Board ★★★★★★★★

Chairwoman Donna Salamone called the meeting to order at 6:19 PM in the Board Room at the Schuyler Town Office, 2090 State Route 5, Utica, NY 13502.

Other Planning Board members present were Vice Chair David Fusillo, Victor Costanza, James Digristina, Jean Finster, Daniel Tripoli, Michael Ritter and Alternate Member Dale Dodge.

Other Town officials present were Supervisor Anthony J. Lucenti, Codes Officer Philip Green, Administrative Assistant Jeff Dingman, and Bette Szesny, who serves as Recording Secretary.

Also present was Town resident Richard Finster.

Ms. Salamone led the Board and assembled persons in the Pledge of Allegiance to the Flag.

PROPOSED NEW WATER DISTRICT IN EAST SCHUYLER

Ms. Salamone stated this meeting will include a report from Supervisor Lucenti regarding a possible public water project to extend the existing MVWA (Mohawk Valley Water Authority) water lines from the Thruway Service Area at Carder Lane/Route 5 to adjoin with Ilion's proposed project.

Supervisor Lucenti then took the floor to provide an overview of this possible extension of Schuyler's municipal water lines, as follows:

The Town of Ilion had contacted Supervisor Lucenti to ask whether the Town of Schuyler might be interested in joining Ilion to extend our public water services further east. Supervisor Lucenti stated a meeting was held on October 25, 2018 at the Town Office, when several local officials met with key members of the MVWA to discuss a possible joint project.

It was learned that Ilion's water supply had become inadequate to serve the needs of the community's residents; in an effort to obtain a better alternative, they had contacted the MVWA. Meetings with MVWA and Herkimer County officials and an engineering firm have confirmed a joint project to extend Schuyler's public water service further eastward is possible.

Schuyler's new service area would extend from the existing water district on Route 5 in East Schuyler which originates from the Thruway Service Area (off Carder Lane), and ends at the Schuyler/Frankfort Town Line at the Frankfort Bridge (approximately 5 miles of new lines); and could include many of the larger populated side roads in East Schuyler, as well. This joint project with the Village of Ilion would require larger diameter piping (approximately 18" to 24") to accommodate Schuyler's needs. Preliminary studies have revealed the existing water tank on Windfall Road will help to support the required amount of water for the potential new users; as well, a pumping station will likely not be required.

In the event Schuyler chooses not to join in on this project, smaller piping would be installed; however, if in sometime in the future Schuyler decided to extend its water lines to adjoin this target area, installation of larger piping would then be required, resulting in a much higher expense to the prospective new Schuyler water customers. It was stated that sewer pipes (if installed at some later date) would need to be placed 10' from the water pipes. Grant funding will be sought to offset the cost of infrastructure. Supervisor Lucenti will be meeting with the engineers next week to discuss this project in further detail.

Questions were posed by Mr. Ritter and Mr. Costanza with regard to annual cost of the bond, the cost of hookup, and water usage charges. Supervisor Lucenti stated the bond, which would be placed on the individual tax bills of each property owner in the new district, would likely be in the ballpark of \$500 per parcel, for a period of 30 years. Many variables, including the size of the parcel, land use, and the assessed valuation of each parcel of property could determine the property owner's assessed amount for the bond; however, that has yet to be determined. Cost to hook up to the system (which is not mandatory) is indeterminate and is based on the distance from the water lines to the



residence, while water usage billing statements are sent to each water customer, reflecting that resident's usage for the particular billing period, as reflected on their water meter.

Supervisor Lucenti stated an interest survey will be sent out to all residents of the proposed new service area, which is yet to be determined by the engineering firm. If sufficient interest is shown in the responses, the project will move forward with engineering studies, and ultimately (following a cost-per-user for the annual bond amount and predicted water usage cost are established), a water district will be formed, followed by a referendum vote of the property owners of the proposed new water district.

NEW FLOOD PLANE MAP

Supervisor Lucenti reported Herkimer County has completed their work on the new County Flood Plane map. The new map represents better identification of newly defined Flood Plane areas throughout the county, and it will serve as a great asset to the Town of Schuyler.

REVISED ZONING MAP

Supervisor Lucenti reported Jeff Quackenbush from the County Planning's Mapping Dept. will attend next month's meeting to confer with the Planning Board regarding some properties appear to be split into two zones. This may require re-zoning of some properties so as to enable any given property to be situated in a single zone.

SOLAR GRANT

Supervisor Lucenti reported there has been no word on a solar grant award.

MASTER PLAN UPDATE

Supervisor Lucenti reported the Town's Master Plan Update is approximately 70% completed. Administrative Assistant Jeff Dingman has been instrumental in compiling the data to be included in this updated Master Plan.

TOWN BUSINESS & AGRICULTURAL SURVEYS

Supervisor Lucenti reported only a few business and agricultural surveys were returned to the Town; therefore, this effort has been suspended.

SEWER MAINTENANCE PROGRAM: BRUSH CLEANING — BY MOHAWK VALLEY MATERIALS

Supervisor Lucenti reported Mohawk Valley Materials has completed their work to clean out the brush along the canal in preparation for the maintenance work on Schuyler's sewer system, which will commence in the Spring of 2019, as soon as the weather permits.

GREEN WAVE RECYCLING

Supervisor Lucenti reported Green Waste Recycling has completed their purchase agreement on the former Chandler property on Route 5 in East Schuyler. In response to Michael Ritter's inquiry, Supervisor Lucenti reported the company has secured the security bond mandated by the ZBA, and they have provided documentation of same to the Town of Schuyler.

DOLLAR GENERAL STORE

Supervisor Lucenti reported he has received word from DG-Utica that construction of the new store is scheduled to commence shortly, and will continue through the upcoming months to completion.

ADJOURNMENT

No further business was brought before the Board; therefore, the meeting was adjourned at 6:40 PM, on a motion by David Fusillo and seconded by Daniel Tripoli.

MINUTES OF NOVEMBER 14, 2018

Motion by Szesny, second by Dodge that the Town Board dispense with the reading of the minutes of November 12, 2018 and approve them as printed; all in favor.

RESIDENT COMMENT

A Town resident who lives in Heritage Acres Mobile Home Park wanted to know what was done. Codes Enforcement Officer Phil Green said he went and spoke to the persons involved in the matter, and the mobile homes are being fixed up, and as well, the property was cleaned up.

ASSESSOR'S REPORT — BY GEORGE HASKELL

Assessor George Haskell said he will be stuffing envelopes to be mailed the 1st of January, for the Star Program. He said the income level will be \$86,300.00.

CODES REPORT — BY PHILIP GREEN

Codes Enforcement Officer Philip Green said a portion of his report was already mentioned in Resident Comment. He said he attended the Flood Plain Meeting and if you are in that area you must purchase flood insurance otherwise FEMA will not pay. Mr. Green said they have flood plain maps, but they are not official as of yet.

SUPERVISOR'S REPORT — EAST SCHUYLER WATER EXTENSION

Supervisor Lucenti said he met with the Engineer regarding the water extension. He said it all revolves around the elevation of the land without a pumping station. He said without a pumping station the elevation is around 512 feet. He said by tomorrow they should have a map with elevation, after that the engineer will drive around and see what is vacant and what is populated land.

Motion by Kane, second by Dodge, to appoint Deborah Windecker to the Board of Assessment Review from 10/01/2018 to 09/30/2023; all in favor.

Supervisor Lucenti said the Town Board has a list of the preliminary appointments for 2019, and there have been no changes.

CONTRACT WITH STEVEN SWAN HUMANE SOCIETY

Motion by Kane, second by Szesny, that the Supervisor sign the contract with Steve-Swan Humane Society for dogs, there will be no cats covered in this contract; all in favor.

CHRISTMAS BONUS FOR HIGHWAY & CLERICAL IN THE AMOUNT OF \$50.00

Motion by Dodge, second by Juliano, authorizing a \$50.00 Christmas Bonus to Highway & Clerical; all in favor.

**USDA PUBLIC HEARING ON INTENT TO FILE APPLICATION — JANUARY 9, 2019 AT 5:45 PM**

Supervisor Lucenti said there will be a Public Hearing on January 9, 2019 at 5:45 PM regarding the intent to file an application with the U.S.D.A. for a low interest rate, if we do not get the grant.

ANNUAL INSPECTION OF TOWN CLERK & COURT CLERK RECORDS

Supervisor Lucenti said the Town Clerk & Court Clerks records will be inspected by Eric Kane and Joe Juliano on January 9, 2019 at 10:00 AM.

HIGHWAY REPORT — BY ACTING SUPERINTENDENT OF HIGHWAYS PHILIP JOHNSON

Acting Superintendent of Highways Philip Johnson said they have been using the Ford 550 and it is working well. He said it originally came with the wrong snow flap and the right flap should be coming in shortly.

Acting Superintendent of Highways asked the Town Board if Highway could carry over any not used sick time or personnel time, up to two weeks in 2019.

Motion by Dodge second by Kane authorizing any not used sick time or personnel time for up to two weeks starting in 2019; all in favor.

Acting Superintended of Highways also stated that the main overhead door should be replaced. It has been repaired several times and what happens is the water gets into door and problems occur with the door opener. He said we have had it repaired many times. He was advised to go ahead and get a quote.

FEMA FLOODWAY PLAIN AREA — BY JOE JULIANO

Councilman Joe Juliano said there was a meeting on 11/28/2018 regarding flood plain. He said if you live in flood plain area, you must purchase flood insurance and if there is a problem then F.E.M.A. will help, but you must purchase flood insurance. He said the meeting was open to the public, and they had representation from Insurance Companies there. He said there is a flood plain map in the hallway of the office building, and they are working on a new map. He said if you contest the flood plain map then you have to hire an engineer to prove otherwise.

SEWER LINE CLEARING — BY JOE JULIANO

Councilman Joe Juliano said he took a walk alongside the Thruway, to inspect the clearing. He said he went to from Marker 231 to 232, and it is rough clearing. He said it is not what I expected. He said they are using a Skidsteer, which got stuck, and a mini excavator. He said he expected to see the \$400,000.00 machine. Acting Superintendent of Highways Philip Johnson said they tried to use the big machine by coming in on Leland Ave., and they could not make it. Councilman Joe Juliano said he will be watching the clearing very closely. Councilman Kane said maybe we should have paid \$1,000.00 for the permit. Councilman Joe Juliano said we have access.

REPORT BY PARK RANGER

The Town Clerk said there is nothing going on.

WATER BOARD REPORT — BY BETTE SZESNY

Councilwoman Szesny said she had a request regarding tenants' responsibility for water bills. She said the landlord can bill the tenant for water usage, but payment of the water bill s the landlord's responsibility. Councilwoman Szesny said there is nothing else to new to report, other than this is Eric Kane's' last month on the Water Board.

PLANNING BOARD REPORT — BY BETTE SZESNY

Councilwoman Szesny said they are still working on the Master Plan updates as well as the Zoning Map and Solar. She said regarding the Business and Agricultural surveys, there was not a great amount of response.

RESIDENT COMMENT

Town Resident Clarence Caldwell said he has seen little ponds past the thruway bridge and was advised those are Beaver damns.

Supervisor Lucenti said he wants to thank the Town Board for all the work that has been done in 2018. He said he wants to also thank Jeff Dingman for all the work he has done.

There being no further business to come before the Town Board the meeting was adjourned.

2019 Star Program Changes

New York State Dept. of Taxation & Finance has announced changes to the 2019 STAR Program. Property owners age 65 and over need to be aware of the following changes:

In order to receive the Enhanced STAR exemption, you must enroll in the Income Verification Program (IVP). Enrollment only has to be done once, and if you are eligible for the Enhanced STAR exemption, you will automatically receive it each year.

The IVP will ensure that individuals no longer meet renewal deadlines and will no longer have to provide income tax returns to their local assessor's office. *If you are already receiving the Enhanced STAR exemption and are already enrolled in the IVP, you do not need to take any action.* The NYS Tax Dept. will contact you directly if any additional information is needed.

- *If you are already receiving the Enhanced STAR Exemption and are already enrolled in the IVP, you do not need to take any action.* The NYS Tax Dept. will contact you directly if any additional information is needed.
- *If you are already receiving the Enhanced STAR exemption and are **NOT** enrolled in the IVP, you must renew your application for the Enhanced STAR and enroll in the IVP.*

In addition, individuals who qualify for the senior citizen exemption will no longer automatically receive the Enhanced STAR exemption. You must apply for the Enhanced STAR Exemption separately.

Individuals who are new homeowners or first time STAR applicants need to first register for the STAR credit with the NYS Tax Dept. instead of applying for the exemption. Additional information about the STAR credit can be obtained at www.tax.ny.gov/STAR (or by phone: (518) 457-2036).

In December, Town residents who currently receive the Enhanced Exemption will receive Form RP-425 RNW and RP-425 IVP. You must return both completed forms, plus a copy of your 2017 Federal 1040, Page 1, Income Tax form by March 1, 2019.

Alternate Parking Law Now in Effect

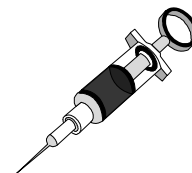
