• **TOWN CLERK & COURT CLERK BOOKS:** Supervisor Lucenti said Councilmen Joe Juliano & Eric Kane checked the Town Clerk's books and found them to be in good order.

Motion by Szesny, second by Juliano, for the Town Supervisor to sign the agreement with Town of Schuyler Volunteer Fire Co., Inc., in the amount of \$192,287.00, payable in two installments: \$96,143.50 in February, and \$96,143.50 in July, 2020.

• **ANIMAL SHELTERING AGREEMENT WITH STEVENS-SWAN HUMANE SOCIETY:** Supervisor Lucenti read the Animal Sheltering Agreement with the Stevens Swan Humane Society.

Motion by Dodge, second by Juliano authorizing the Supervisor to sign the agreement with Stevens-Swan Humane Society, omitting cats.

Dodge: Aye, Juliano: Aye; Kane: Aye; Szesny: No — (because cats were not included); Lucenti: Aye.

Supervisor Lucenti said he wanted to thank the Town Board for all the help he has received from them. He said we have made progress in getting grants for water and sewer work.
